Note: Irrigation water connection size will be charged at 1.5 times the established Equivalent Residential Unit Rate for the System Development Charge.

## 2C. Inclusion Fee

\$3,200 per EQR or \$14,400 per acre paid prior to inclusion. Legal, engineering and administrative costs as determined by the District must be escrowed with the District prior to any negotiations with the developer for reimbursement of any and all costs incurred by the District.

## 2D. Plan Review Application

\$750 plus \$25.00 per lot.

If more than two construction plan reviews are necessary, the Developer will be charged for any additional costs.

## 2E. Developer Field Work Permit

Fees will be determined after review of the construction plans. Fees will be paid prior to the Pre-Construction Conference and prior to the start of construction. Additional fees will be charged to the Developer if re-inspections are necessary.

## 2F. Hydrant Meter Rates

Developer Administrative Fees:** RWSD will invoice 15% of engineering and legal fees to cover the costs required of our employees to do work required by developers, etc. to make changes to the District's infrastructure. If you would like to be billed straight hours rather than the 15% the billing rates are as follows:
